## Replacement Payment of Unpaid Wages

Mibarai Chingin Tatekaebarai Seido



A system to replace 80% (there is an upper limit) of unpaid wages of a bankrupt company (Labor Standard Inspection Office)

## **Public Assistance**

Seikatsu Hogo





Payment of living expenses, rent, medical expenses, etc. if the income is less than the minimum living expenses (local government)
